# Vice President's Report – Jeff Sterling

Completed all documentation for the Mentoring Program. The program is now active and will be offered to all incoming new members of the Colonel William Grayson Chapter. The program is optional and will begin with the new member receiving a document describing the basic aspects of the SAR, its functions and methods including the Colonel William Grayson Chapter. If the new member desires a Mentor, it will be followed by one-on-one discussions with the new member to determine his desired goals and objectives within the SAR, and guidance will be offered to assist in orienting the individual and begin his involvement in the organization. # <u>Registrar's Report: Mike Blythe</u>

Halfway through the year, and to date we've had twelve new member applications approved – that's a pretty good haul. Ten more are in the queue waiting for review either at the National Headquarters or with the State Registrar. My hope is we will welcome many new compatriots in October. The latest new member application to be approved took three and a half months to complete the process, which marks a small improvement. Supplemental applications take sixty-three weeks.

In addition to these new members, we identified two "Forgotten Patriots" in June; the patriot ancestors of our compatriots Lanny Tuthill and Gordon Strong. A forgotten patriot is one who has not been previously accepted as a patriot ancestor by either the SAR or DAR or whose previously approved line has been closed due to flaws in the original application. In both cases, the DAR had closed the lines because they found evidence associating Patriots Nathan Tuthill and Selah Strong with expressions of loyalty to the crown, or in Tuthill's case mistook him for someone who did. Additional evidence provided by local historians in Long Island proved the DAR wrong in both instances and the applications were approved and new forgotten patriots documented. Their descendants will be recognized at the October meeting. You may remember Selah Strong and his wife Anna from the TV drama series "Turn: Washington's Spies." Gordon Strong is his great-great-great-great grandson.

As of 1 September 2024, the cost of applying to the SAR increased to \$257: \$150 NSSAR new member application fee, \$50 first year's dues, \$12 VASSAR, and \$45 Col William Grayson Chapter. Junior Member applications increased to \$107: \$75 NSSAR application fee, \$5 first year's dues, \$12 VASSAR, and \$15 Col William Grayson Chapter.

# **PWC Revolutionary War Memorial – Ross Schwalm**

Compatriots, thank you for answering the call to donate to the Prince William County Revolutionary War Memorial fund started at our chapter. To date, \$2175 is the amount you have collectively donated towards our chapter goal of \$5000.

Dave Button and I were at the first meeting for this project on March 1, 2022 and the progress made has been tremendous. The county board of supervisors approved \$130,000 for the FY 25 County Budget so detailed design will start this summer. I personally plan to spend several days a week at Williams Ordinary to ensure we continue to guide the project and raise more funds. # April 19, 2025: Remembering Lexington and Concord - Aldie, Virginia

President Andrew Mills, Quartermaster Jack Mills, and Compatriot Greg Hall took part in a reenactment and President Mills presented the Chapter wreath.





#### April 23, 2025: SAR Heroism and Life Saving Commendations to Virginia State Police Troopers.

Compatriot Bill Collier presented the SAR Heroism and Life Saving Commendations to Virginia State Police Troopers. The location of the presentations was at Virginia State Police Office Number 48, 9801 Braddock Road, Fairfax Virginia.22030.

The Heroism Commendation was presented to Virginia State Police Trooper Scott A. Jeltema. His Citation reads:

On Monday, November 25, 2024, troopers were in pursuit of a stolen vehicle that ultimately ran a red light at high speed and crashed, bursting into flames. Trooper Jeltema was the only trooper present at the end of the pursuit. The vehicle was occupied by four juveniles and due to the force of the collision, one of the juveniles was partially ejected and became trapped in the vehicle's front windshield. Amidst shattered glass and debris scattered across the scene, with flames erupting from the engine bay, Trooper Jeltema placed himself in imminent danger to save the life of the trapped juvenile. Despite the growing smoke and the constant risk of an explosion, Trooper Jeltema remained focused on the rescue. With tremendous strength and resolve, he managed to pull the unconscious juvenile out of the windshield, performing a daring rescue from the top of the burning vehicle.

The Lifesaving Commendation was presented to Virginia State Police Trooper Sesaly Barden. She was one of three State Troopers involved in the commendation. The other two presentations will be accomplished at a later date. Her citation reads:

On Thursday, August 15, 2024, troopers were involved in the pursuit of a vehicle linked to the kidnapping of three children, ages 16 months, five, and seven years old. The vehicle, driven by their biological father who had kidnapped the children after stabbing their mother and older brother, crashed at high speed during the pursuit. Upon approaching the vehicle, the troopers were met with a horrifying situation. The father held one of the

children up as a shield. Despite this, the troopers successfully apprehended the father and rescued the five and seven-year-old boys. However, it was then discovered that the 16-month-old girl who had also been kidnapped was unconscious and bleeding from her head on the backseat floorboard. Senior Trooper Vaiglova and Trooper Barden displayed remarkable compassion and care as they tended to the two young boys who had endured unimaginable trauma within the preceding 24 hours, witnessing their mother and brother being stabbed and being abducted by the very person meant to protect them. One of the boys had suffered a broken leg and was in excruciating pain. Senior Trooper Vajglova and Trooper Barden provided comfort, administering both physical and emotional care. They gave the boys "Trooper Teddies" to hold, offering a sense of security in the midst of chaos. Their extraordinary empathy and attention to the boys will undoubtedly leave a lasting impact on the children's lives. Meanwhile, Trooper Chappell rendered critical life-saving care to the 16-month-old girl. As the Division's CPR instructor, Trooper Chappell's skills and experience made him exceptionally suited for the task. He performed CPR on the toddler and refused to stop until Emergency Medical Services arrived 15 minutes later. Throughout the ordeal, Trooper Chappell provided continuous updates on her condition, which were relayed to fire and rescue teams enroute to the scene. His unwavering efforts extended the child's life, giving her a fighting chance. She was airlifted to the Children's National Hospital in Washington, D.C. but tragically succumbed to her injuries shortly after arrival. The actions of Senior Trooper Vajglova, Trooper Chappell, and Trooper Barden exemplify the highest standards of professionalism, compassion, and humanity. The heinous act of kidnapping three innocent children, compounded by the violence perpetrated by their own father, was an unimaginable tragedy. Yet the troopers rose to the occasion, offering not only immediate life-saving care, but also emotional support to the surviving boys in the aftermath of this horrific event.

#### May 21: SAR Heroism Commendations to Virginia State Police Troopers.

Compatriot Bill Collier presented SAR Heroism Commendations to Virginia State Police Senior Troopers James L. Collins and Monica D. Hart. The commendations were presented to the State Troopers at the Virginia State Police Area 45 office in Arlington, Virginia.

#### Their Citation reads:

Virginia State Trooper James L. Collins and Monica D Hart's courage in the face of imminent danger was exemplified during a recent pursuit related to an amber alert. They were alerted to a vehicle linked to a missing children case, driven by a male suspect wanted for abducting his three children—aged 16 months, 5 years, and 7 years—after stabbing his stepdaughter and the children's mother multiple times. In response, the Virginia Beach Police Department requested the issuance of an AMBER Alert, which was promptly activated. Responding, both Troopers positioned themselves in monitoring the suspected vehicle. As the pursuit began, Trooper Collins exhibited composure under pressure, maintained communication with dispatch, provided accurate updates on the pursuit's speed, and coordinated effectively with fellow troopers. During the pursuit, he successfully navigated traffic, reaching speeds of up to 125 mph. His decisive actions and leadership were instrumental in bringing the suspect vehicle to a stop and ensuring the safe recovery of two of the abducted children. Acting as backup, Trooper Hart's actions were crucial in the apprehension of the suspect and the safe recovery of two abducted children after the pursued vehicle crashed. Specifically, she carried one child, who had a broken leg, from the vehicle while the suspect was still unsecured inside. Senior Troopers James L. Collins and Monica F. Hart exemplified the core values of the Virginia State Police: professionalism, integrity, and dedication to service.

Officer Juranek's citation reads:

On October 24, 2023, Officer Juranek displayed extraordinary courage and dedication to duty in a life-threatening situation that unfolded in a Chantilly intersection. Responding to a call involving a man with blood on his shirt,

Officer Juranek was met with an unexpected escalation when updated information revealed a subject armed with a knife was chasing the injured individual. The armed man had fled prior to arrival; however, the officers discovered the bloody man seated in the passenger seat of a Good Samaritan's vehicle. Shockingly, he was suffering from several stab wounds to his upper torso, head, and neck. He applied a Tactical Emergency Casualty Care kit (TECC), and applied chest seals to the more significant wounds. Despite the gravity of the situation, Officer Juranek remained calm and reassuring, instilling hope in the victim that he would be okay. Officer Juranek's actions epitomize the highest standards of law enforcement and exemplify the values of courage, compassion, and selflessness.

#### June 13, 2025: Special Naturalization Ceremony – Gunston Hall, Virginia

#### June 13, 2025, SAR Life Saving Certificate and Medal to Fairfax County Police Department Officers

Compatriot Bill Collier presented the SAR Life Saving Certificate and Medal to Fairfax County Police Department Officers First Class Henry D. Viar and Kyler S. Racey. Their citation reads:

On the evening of August 20, 2023, PFC Henry Viar and PFC Kyler Racey responded to a shooting call for service, in a parking lot off of Route 29, in Centreville. Both officers arrived in the parking lot at the same time and encountered two community members trying to assist another community member who had just shot herself in the chest, while seated in her vehicle, in an attempt to commit suicide. The community members were trying to hold a sweatshirt against the victim's chest and apply pressure. PFC Racey quickly took over applying pressure to the chest while PFC Viar utilized the TECC (tactical emergency casualty care) kit from his police vehicle. Both officers confirmed the gunshot was to her chest. PFC Viar took out chest seal from the TECC kit and the two worked together to quickly lift the sweatshirt and apply the chest seal. However, the victim was bleeding so much that the chest seal was not able to be applied. PFC Racey continued pressure by replacing the sweatshirt and held it to stop the bleeding. PFC Viar continued to keep the victim calm. Both officers maintained their situational awareness by ensuring the firearm was no longer reachable by the victim. Fairfax County Fire and Rescue units arrived and these officers' actions allowed paramedics to set up their equipment and come up with a plan to quickly move her from the driver's seat to the ambulance gurney. This was done seamlessly by PFC Viar and Racey, who were then relieved by paramedics. These officers' quick response, action, and poise ultimately provided valuable time to control the bleeding till paramedics could arrive and begin advanced life support. The victim was ultimately transported to Fairfax Hospital where she ultimately survived this suicide attempt and was able to get mental health services.

# Historical Notes:

### The Virginia Gunpowder Plot of 1775



In April 1775, Royal Navy sailors, under the direction of the Governor, Lord Dunmore, arrived in Williamsburg with the intention of removing all of the gunpowder from the public magazine and transporting it to the British ship HMS *Magdalen*. Townspeople discovered what was happening and raised an alarm. An incensed crowd gathered and faced the governor and his servants who were now armed with muskets. Town officers demanded the return of the powder, claiming it was the property of the colony to which the royal governor had no right. Lord Dunmore said that he had learned of a planned slave uprising and was removing the powder for reasons of public safety. The Speaker of the House of Burgesses, Peyton Randolph calmed the situation, at least for the moment.

Suspicions of the governor's motives persisted. On April 22, after a second angry crowd, fully capable of storming the Governor's palace, was convinced to disperse by local leaders, Lord Dunmore angrily declared that if attacked he would, "...declare freedom to the slaves, and reduce the city of Williamsburg to ashes."

By April 29, militia men all over Virginia had learned about the battles in Massachusetts at Lexington and Concord on April 19. Hundreds of men mustered at Fredericksburg and decided to send a messenger to Williamsburg before marching on the capital. Once again, Peyton Randolph sought to prevent violence and urged restraint. The militiamen at Fredericksburg voted not to march. But there were others who were more hot-headed. On May 2, the Hanover County militia, led by Patrick Henry, voted to march on Williamsburg. On May 3, Patrick Henry and the militia were fifteen miles from Williamsburg. Lord Dunmore and his family

# departed for the governor's hunting lodge, Porto Bello, and from there to HMS *Fowey* at anchor in the York River.

Moderates were still looking for ways to ease tensions. Carter Braxton, a moderate member of the House of Burgesses came up with a solution. Braxton negotiated a settlement with royal officials such that the colony would receive payment for the gunpowder. On May 4, Patrick Henry received a full bill of exchange, signed by an intermediary (a wealthy planter), as payment for the powder. A triumphant Patrick Henry then set off for Philadelphia to take his place as a Virginia delegate to the Second Continental Congress, where he presented the payment to the other Virginia delegates at the Congress.

On May 6, Lord Dunmore issued a proclamation charging that the money had been extorted and that "a certain Patrick Henry...and a number of deluded followers who had organized an independent company and put themselves in a posture of war be arrested as traitors."
