**Abigail Adams** may be awarded to a DAR member for two or more approved applications submitted with a DAR Finder Form.

**Deborah Sampson** may be awarded to a DAR member for five or more approved applications submitted with a DAR Finder Form.



**Lucy Knox** may be awarded to a DAR member for eight or more approved applications submitted with a DAR Finder Form.

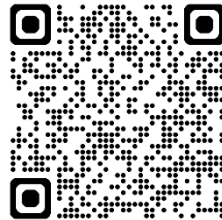


**Recognize DAR State Support  
to Recruitment with the  
DAR Finder Form**

The DAR Finder Form must be forwarded *WITH THE SAR APPLICATION* – Ask the SAR Registrar to put the Finder Form on top of each new SAR application. Keep a copy. Follow up with the chapter and state registrar.

The Registrar at the SAR National Headquarters will then use these forms to determine the winners of the DAR/SAR membership award, presented to the DAR State Society that recruits the most new members and the highest percentage of new members to the SAR. A total of \$1,200 is awarded each year.

Since 1990 the NSSAR has recognized the support from the Daughters of the American Revolution (DAR) in recruiting new members to the SAR through two competitive awards, The DAR/SAR Membership Award (SAR Handbook Vol. VI). In 2025 three non-competitive medals, to be given to individual DAR members for excellence in recruiting support were added to the SAR awards which may be conferred to members of DAR.

The awards and requirements follow:

The DAR/SAR Membership Awards (SAR Handbook Vol. VI), authorized in 1990, are presented to the DAR State Societies that recruit the most new members to SAR. This is a two-track system:

1. The first is using a leveling formula by percentage using the highest percentage with the number of applications that have the DAR finder form submitted versus the total number of applications submitted taking into account the State Society total of active members. The DAR State Society that has the highest score of participation as a factor of participation in the program will be awarded certificates and \$300 for 1st place, \$200 for 2nd place, and \$100 for 3rd place to the DAR State Society.

2. The second track is State Societies with the highest raw numbers of approved SAR members using the DAR Finder Form, with \$300 for 1st place, \$200 for 2nd place, and \$100 for 3rd place to the DAR State Society.

Separately, the SAR has authorized a new three-tiered award, recognizing individual DAR ladies for their contributions by nominating SAR candidates resulting in new members. Awards are tabulated and awarded at the time and location determined most appropriate by the Chapter or State presenting the award. Note – attainment is cumulative and OLCs are authorized for each medal. Qualifications for each medal are as follows:

1. Abigail Adams may be awarded to a DAR member for two or more approved applications submitted with a Finder Form.
2. Deborah Sampson may be awarded to a DAR member for five or more approved applications submitted with a DAR Finder Form.
3. Lucy Knox may be awarded to a DAR member for eight or more approved applications submitted with a DAR Finder Form.
